

Graduates will receive lesson plans and training materials for use in training members of their agency. The course will cover the following areas: technology overview, electrical and medical background, specifications – how does it work, field applications, safety considerations and associated risks, tactical considerations, and will involve practical hands on training.

Upon completion of this course, the student should be able to:

1. Explain the technology of the TASER weapon, what it is and how it works;
2. Demonstrate the proper use and deployment of the TASER weapon;
3. Explain the tactical considerations for TASER weapon use;
4. Demonstrate how to change batteries, air cartridges, and conduct firing drills;
5. Design and conduct practical training scenarios;
6. Train and certify members of their agency on the use of TASER® X26 and X2.

This course is designed to meet requirements as mandated by the Maryland Police and Correctional Training Commissions.

Since we are **restricted to 25 people** in the class, we suggest a quick response be made to reserve your seat/s.

This course has an online component that MUST be completed prior to attending the two practical days of instruction with a TASER Master Instructor. Once registered from one of the links below, the student will receive an email confirmation from NWTC with their username and password. This will allow them to access the Blackboard online training.

Important Note: This is a two part course. You must complete the online training through TASER International and attend the classroom training at the Eastern Shore Criminal Justice Academy.

Registration Procedures

You must follow the below registration procedures in order to be enrolled in this class.

To complete the online part:

- 1 To register for the course, go to <http://www.taser.com/training/Pages/events.aspx>
2. Click on the state you are interested in.
3. Click on that particular class.
4. You will then need to click the "New" certification. You will then be linked to TASER International's affiliate, NWTC (Northeast Wisconsin Technical College).
5. If you have never registered on their site, you will have to "Create New Organization" or "Create New Student".
 - a. You will need to enter information that is required by TASER Int'l and NWTC
 - b. Enter payment information such as credit care or purchase order number
6. Once registered you will receive an email with your log-in identification number and password.



You will need to log-in to take the online portion of the class three weeks before the in-classroom/practical portion takes place. You will have two weeks to complete this process as the online part will close three days prior to the practical day.
