**Prerequisite:** You must have previously attended and successfully completed a LEEMCC course or First Responder course. Please bring your current first responder card with you to class.

Up to one year after your LEEMCC certification expires you must do the recertification class, **beyond one year** you must complete the entire 25 hour class.

The Law Enforcement Emergency Medical Care Course (LEEMCC) was developed in 2007 and 2008 in response to the Maryland law enforcement community's request to create a medical course with specificity and applicability to law enforcement's needs. This course is designed for the individual seeking to renew their certification. The course addresses major medical, trauma, and resuscitation situations encountered by law enforcement officers, including a unique Care Under Fire.

## Upon completion of this course, the student should be able to:

- 1. Demonstrate proper patient assessment of a medical and trauma patient;
- 2. Recognize and manage traumatic bleeding emergencies;
- 3. Recognize and provide applicable care under fire;
- 4. Demonstrate and successfully pass a CPR test and practical;
- 5. Understand how to reduce or eliminate responder and motorist injuries and fatalities at incident scenes.

This course is designed to meet requirements as mandated by the Maryland Police Training Commission and to meet the annual in-service requirements.

Class Size:

Seating limited.

Attendance:

You must attend the entire course to receive in-service credit.

### **Dress Code:**

In order to maintain a professional appearance, all in-service officers/staff must follow the prescribed dress code to be admitted to any training held at the Academy.

- Uniform of the day recommended
- Shirt with a collar—No t-shirts or tank tops
- Docker style pants, BDU's or suit—No shorts or jeans
- Full shoe with socks—No sandals

**Firearms**—All officers wearing a handgun on campus in plain view <u>MUST</u> also wear his/her badge in plain view.
