This course is designed for police officers, fire personnel (fire fighters), and EMS personnel. This is a 24-hour performance level direct delivery course designed to improve integration between law enforcement, fire, and emergency medical services (EMS) in active shooter events. The course provides law enforcement officers with key medical skills based on tactical emergency casualty care (TECC) guidelines which can be used at the point of injury (POI) to increase survivability of victims. The course also provides a model framework for law enforcement, fire, and EMS to integrate responses during an active shooter event through the rescue task force concept using the Active Shooter Incident Management Checklist.

Upon completion of this course, the student should be able to:

1. Use the Active Shooter Incident Management Checklist in managing an integrated response to active shooter events.
2. Identify appropriate life saving techniques that can be used in a direct threat environment.
3. Identify appropriate lifesaving techniques that can be used in an indirect threat environment.
4. Discuss the initial response priorities to an active shooter event and tactical consideration for a swift response by law enforcement, fire, and emergency medical services (EMS).
5. Understand staging and how to function as a Staging Area Manager in an active threat integrated response.
6. Discuss and demonstrate advanced medical skills based on tactical emergency casualty care (TECC) and National Incident Management System (NIMS) guidelines (medical provider participants only).
7. Respond to a simulated active shooter incident and successfully integrate the response between law enforcement, fire, and emergency medical services (EMS) to quickly mitigate the threat while increasing the survivability of injured persons.

This course is designed to meet requirements as mandated by the Maryland Police Training Commission and to meet the annual in-service requirements.

Class Size: Seating limited.

Attendance: You must attend the entire course to receive in-service credit.

Dress Code:

In order to maintain a professional appearance, all in-service officers/staff must follow the prescribed dress code to be admitted to any training held at the Academy.

- Uniform of the day recommended
- Shirt with a collar—**No** t-shirts or tank tops
- Docker style pants, BDU's or suit—**No** shorts or jeans
- Full shoe with socks—**No** sandals

Firearms—All officers wearing a handgun on campus in plain view MUST also wear his/her badge in plain view.
