This course is designed for police officers, fire personnel (fire fighters), and EMS personnel. This is a 24-hour performance level direct delivery course designed to improve integration between law enforcement, fire, and emergency medical services (EMS) in active shooter events. The course provides specific technical knowledge and skills relative to each of these disciplines, including key medical skills based on tactical emergency casualty care (TECC) guidelines, which may aid law enforcement personnel in improving the survivability of victims and enhance the skills and knowledge for fire and EMS personnel during an active threat incident.

Participants will discuss rescue task forces (RTFs), basic hemorrhage control and airway management, and organization of a unified response. Additionally, participants will take part in discipline-specific practical exercises that review skills in either law enforcement tactics or medical response. All participants will engage in a large-scale practical exercise that tests all of the concepts and skills introduced and practiced throughout the course.

Upon completion of this course, the student should be able to:

1. Explain the need for responders and their agencies to prepare for an active threat incident before it occurs.
2. Describe the components of integrated command and the initial responder response model structure for an active threat integrated response.
3. Identify appropriate lifesaving techniques that can be used in a direct and indirect threat environment.
4. Perform advanced medical skills appropriate to a post casualty collection point environment.
5. Perform basic medical skills appropriate to an indirect threat care environment.
6. Operate tactically in an active threat environment.
7. Implement a staging area and rescue task force for a swift, integrated response by law enforcement, fire, and emergency medical services.
8. Employ appropriate lifesaving techniques that can be used in a direct or indirect threat environment.
9. Integrate law enforcement, fire, and emergency medical services (EMS) into a unified response to an active threat.
10. Explain how coordination and resource integration between law enforcement, fire, and emergency medical services (EMS) increases effective response to active threat and mass casualty incidents.

This course is designed to meet requirements as mandated by the Maryland Police Training Commission and to meet the annual in-service requirements.

Class Size: Seating limited.

Attendance: You must attend the entire course to receive in-service credit.
